#### I. COMPANY PROFILE

The Brahmaputra Valley Fertilizers Corporation Limited (BVFCL) was incorporated in 2002 under the Indian Companies Act 1956 with the objective to de-merge the Namrup I, II and III plants from Hindustan Fertilizer Corporation Ltd.
